<b>ATTENTION:</b>	<b>THERE WILL BE NO DISMANTLING OF BOOTHS ALLOWED DURING SHOW HOURS.</b> LARGE WAREHOUSE CARTS ARE AVAILABLE TO MOVE YOUR MERCHANDISE. AN EASY AND CONVENIENT UNLOADING & LOADING AREA IS LOCATED ADJACENT TO THE SHOW AREAS. VEHICLES ARE TO BE MOVED FROM LOADING AREAS PROMPTLY AFTER LOADING AND UNLOADING IS COMPLETED. NO CARTS OR LOADING OF ANY TYPE WILL BE ALLOWED THROUGH GLASS DOORS.		
<b>BOOTH RESERVATIONS:</b>	Checks must accompany signed rental agreement. Check, money order or cashier's check should be made payable to <b>Gibraltar Trade Center, Inc.</b> No refunds will be given once accepted. 	All merchandise must be removed from the building by 11:00 AM Monday morning (no exceptions).		
<b>SALES TAX LICENSE:</b>	Please send a <b>current</b> copy of your Michigan State Sales Tax License with your contract. IF YOU DO NOT HAVE A MICHIGAN SALES TAX LICENSE, YOU WILL BE ISSUED THE STATE CONCESSIONAIRES FORM C-5603.		
<b>SUB LEASING:</b>	Subletting your table space is strictly prohibited. Subleasing will result in removal from the Show and cancellation of future rental privilege.		
<b>SALES AREA:</b>	Exhibitors must conduct business from their own table spaces. Do not solicit customers from any other vendor space, aisleway, entrance or in the parking lot.		
<b>SECURITY:</b>	We have 24-hour outside security and the building is securely-alarmed.		
<b>FOOD:</b>	There is a large food court located in the center of the building.		
<b>SMOKING:</b>	Smoking is prohibited in the building.
