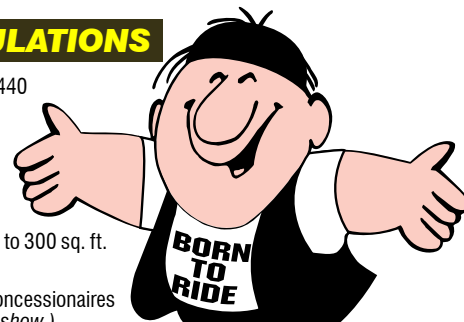

We also reserve the right to ask any or all of a display to be removed from the show if it is deemed to be in poor taste or if the exhibitor does not comply with our rules. You are required to stay for the entire (2) days of the show. I HAVE READ AND DO UNDERSTAND THE RULES AND REGULATIONS STATED ON THE BACK OF THIS CONTRACT FOR THIS SHOW.

- LOCATION:** GIBRALTAR TRADE CENTER NORTH, 237 NORTH RIVER RD., MT. CLEMENS, MI 48043, 586-465-6440
- SET UP:** THURSDAY: 8:30 AM-5 PM FRIDAY: 8:30 AM-9:00 PM
- SHOW HOURS:** SATURDAY: 10:00 AM-8 PM SUNDAY: 10:00 AM-6:00 PM
For those parking trailers in their booths, they **must** be in place by 12:00 Noon on Friday. Hi-Lo's will be available to help maneuver trailers as necessary.
- SPACE SIZE:** 10 ft. x 10 ft. SPACE = \$150.00/space BULK SPACE = \$1.50/sq. ft. (min. 100 sq. ft.)
EXAMPLE: A 22 ft. trailer requires a minimum of three 10 ft. x 10 ft. Booth Spaces or Bulk Space equal to 300 sq. ft.
- HOUSEKEEPING:** Booths and aisles are to be kept clean and clear at all times.
- SALES TAX LICENSE:** Exhibitors are responsible for their own Michigan Sales Tax License or you will be issued the States Concessionaires Form C-5603. (If you have a Sales Tax License, please send us a current copy when you apply for the show.)
- ADMISSION POLICY:** Each Exhibitor will be issued (2) Weekend Admission Passes. Admission passes are required to be shown when entering the premises. Show Exhibitors without an admission pass will be required to pay the \$2.00 admission charge.
- PARKING:** All Exhibitors are required to park in the East Parking Lot near Entrance 5 (Blue Entrance).
- ELECTRICITY:** Electricity is available to most spaces. Please bring any necessary extension cords (14/3 or heavier) as well as any needed power strips. Power strips or cords will not be provided.
- SECURITY:** The building is securely-alarmed and the premises are patrolled 24 hours.
- FOOD:** There are multiple concession areas throughout the Market.
- ALCOHOL:** No alcoholic beverages shall be sold or consumed on the premises except through Gibraltar Trade Center North, Inc. All leased exhibitor areas remain under the complete control of Gibraltar Trade Center North, Inc. as it pertains to the State of Michigan and specifically the Michigan Liquor Control Commission. Gibraltar Trade Center North, Inc. is a licensed provider of alcoholic beverages and all Michigan Liquor Control Commission laws will be strictly enforced.
- SALES TERRITORY:** Dealers must conduct business from their own table space. You may not solicit customers at the entrances or in the aisles and you cannot divert customers from another vendors tables. This type of conduct will result in cancellation of rental privilege.
- COPYRIGHT & TRADEMARK INFORMATION:** This is to inform all Exhibitors of our policy that prohibits sales, display or exhibition of merchandise which infringes upon any trademark, copyright, license of characters, logos, names or other symbols. Any violation of this policy shall be grounds for immediate dismissal from the show.
- SUB-LEASING:** Sub-leasing is prohibited. Any dealer sub-leasing their table space will be removed from the show and will not be able to participate in any future show.
- BOOTH RESERVATIONS:** Checks must accompany signed rental agreement. Check, money order or cashier's check should be made payable to Gibraltar Trade Center North, Inc. No refunds will be given once accepted. A \$25.00 service charge will be enforced on checks returned for insufficient funds, etc.
- CONFIRMATION:** Your receipt will be mailed back to you along with your Weekend Admission Passes.
- MOVE OUT TIME:** All property must be removed from the Show Area by 9:00 p.m.
- ATTENTION:** There will be no dismantling of booths allowed during show hours. All loading and unloading of merchandise must be through one of the service doors adjacent to the show areas. Vehicles are to be moved from loading areas promptly after loading or unloading is complete. No carts or loading of any type will be allowed through any glass doors.
- NOTE:** Vendors must provide customers with a receipt for all purchases over \$25.00 detailing vendor's company name, address and phone number. Please note that the sale of unlicensed products are not allowed in the show.



GIBRALTAR TRADE CENTER NORTH, INC. reserves the right to expel any exhibitor at any time, without cause, with the maximum penalty to GIBRALTAR TRADE CENTER NORTH, INC., being a refund of the rental fee paid by the exhibitor for the show. GIBRALTAR TRADE CENTER NORTH, INC. rents space for the express purpose of selling merchandise that pertains to the show. We reserve the right to order the removal of any items that we consider inappropriate at our sole discretion. Any other activity such as soliciting donations, recruiting club members, fund raising for any organization, etc. is strictly prohibited.
